PLEASE READ CAREFULLY CONDITIONS OF NOMINATION

ELIGIBILITY

1. All greyhounds nominated must be whelped on or after the First of October 2009 and up to and including the 1st of June 2010.
2. All pups whelped between 2nd June 2009 to 30th September 2009 will be allowed in the Auction series as Non-Catalogue pups for a nomination fee of \$500.

THE SALE

3. The sale will be held at the **IPSWICH GREYHOUND RACING CLUB** on **Sunday the 17th of October 2010.**

FEES

Catalogued Pups

4. Early Bird Bonus \$55 per nomination closes 11th June 2010.
Early Bird Bonus \$66 per nomination closes 16th July 2010.
Final nomination \$77 closes 13th August 2010.
Seven or more nominations from each nominator \$55 per pup.

Non Catalogued Pups

5. One – four nominations \$500.
Five or more from same litter \$350.
The first instalment of \$250 must accompany the nomination form. The second instalment is due on or before Monday 11th October 2010.
* **Prior to 31/8/2010 the Ipswich Greyhound Racing Club Inc. reserves the right to cancel the sale through lack of nominations – with all previously accepted nomination fees refunded in full.**
* **Cancellations after the Catalogue is Published will not be eligible for refund.**
6. The Club will charge a fee of 13.75% (GST inc) of the purchase price at the time of sale, which will be deducted from the purchase price. A minimum fee of \$110.00 (GST inc) will apply to any greyhound sold for \$800.00 or less.

AUCTION CONDITIONS

7. Bidding commences at \$800 per pup.
8. The sale will be a no reserve auction and the Club makes no guarantees as to what the purchase price may be.
9. All greyhounds accepted for the sale must be kennelled on the day of the sale by the times the Club notifies.
10. **ALL GREYHOUNDS ACCEPTED FOR THE SALE MUST BE IN A FIT CONDITION. IT IS THE RESPONSIBILITY OF THE NOMINATOR TO ADVISE THE CLUB OF ANY KNOWN CONDITIONS THAT MAY AFFECT THE SALEABILITY OR THE RACING ABILITY OF THE PUPPY.**
- * **11. A SEPARATE CURRENT VACCINATION CERTIFICATE MUST BE PRODUCED AT KENNELING TIME CONFIRMING HEPATITIS, PARVO AND DISTEMPER VACCINATIONS. (NO CERTIFICATE DOG WILL NOT BE ACCEPTED)**
- * **12. IT IS A PREREQUISITE OF THE CLUB THAT ALL GREYHOUNDS SELECTED FOR THE SALE MUST BE PUPPY EAR BRANDED PRIOR TO THE NOMINATION AND PRESENTED WITH ALL RELEVANT PAPERS (FORM F WHICH MUST BE SIGNED FOR SALE BY VENDOR AND VACCINATION PAPERS) WHICH MUST BE PRESENTED TO THE KENNEL SUPERVISOR FOR COLLECTION. THESE WILL BE HELD IN OFFICE UNTIL THE COMPLETION OF THE AUCTION.**
13. All greyhounds accepted for the sale will be paraded in the sale ring by the nominator or his/her appointee. The nominator is responsible for producing the greyhound with a collar and lead.

14. The Club will collect all proceeds from the sale and deduct the appropriate fees and the remainder of which shall be forwarded to the nominator within 21 days.

15. The only exception to Condition 11 will be that, should the highest bidder for a greyhound also be nominator then the greyhound will be released by the Club to that person upon payment of the fee being 13.75% (GST inc) of the purchase price OR the minimum fee of \$110.00 whichever is greater.

THE AUCTION RACE

16. All lots sold through the sale ring on the day of the sale are eligible for the race series in 2012. Only greyhounds purchased through this sale are eligible for the 2012 race series.

17. A written nomination form must be lodged with Greyhounds Queensland before the closing date of the first week of heats of the series. Closing time for nominations for the race to be advised at a later date.

18. A **one off** final acceptance fee of \$77.00 will be payable by the purchaser by the thirty first (31st) January 2012 to be eligible for the race. The Club will notify all purchasers by mail in November 2011 of details for this final acceptance fee.

19. A late acceptance fee of \$550.00 can be paid at time of close of race nominations if the final acceptance fee has not been paid.

20. **IT IS THE PURCHASERS RESPONSIBILITY TO NOTIFY THE CLUB IN WRITING OF CHANGE OF OWNERSHIP OR CHANGE OF ADDRESS. THE CLUB WILL NOT BE HELD RESPONSIBLE FOR ANY PROBLEMS ARISING FROM FAILURE TO DO SO.**

21. The Club offers all prizemoney for Heats, Semi-Finals and Finals.

THE AUCTION SERIES PRIZEMONEY

22. Heats (as many as required) and Semi-Finals will be conducted for the race.

The 520m April Final Prize money will be 1st \$35,000 2nd \$10,000 3rd \$5,000 4th – 8th \$ 500.00

Bonuses for the race will be paid as follows:

Nominators Bonus \$500.00; Breeders Bonus \$2,000.00; Further Bonus paid to winning owner of \$500.00 if winner is by Qld Registered Sire and Further Bonus of \$500.00 if winner is out of Qld Registered Broodbitch; Sire bonus \$500.00 if Stud Dog is Registered in Qld.

NOMINATIONS

23. Nominations for the Auction closes on 13th August 2010 at 3.00pm with the club.

24. All nominees for the sale will be notified in writing of their acceptance.

25. **THE NOMINATION FORM MUST BE COMPLETED IN FULL INCLUDING ALL BREEDING DETAILS. IF A PUPPY EAR BRAND IS NOT DONE AT TIME OF NOMINATION PLEASE SPECIFY ON WHAT DATE THIS WILL BE DONE. AT LEAST 8 LINES OF INFORMATION ON THE PUPPIES BACKGROUND MUST BE INCLUDED WITH EACH NOMINATION, MORE IF POSSIBLE. EG. DAMS RACE TRACK RECORD, SUCCESS OF PREVIOUS LITTERS, CLOSE RELATIONS. ANY NOMINATION, WHICH IS NOT COMPLETE, MAY NOT BE CONSIDERED.**

26. The Ipswich Greyhound Racing Club Inc. recommends that you (as nominator) of a Greyhound/s at the Year 2010 Highland Smash Repair Auction seek your own/independent CPA advice in respect of any GST requirements arising from the sale.

27. Papers and Credits will be held by the Club for 21 Days from the Auction.
