

# Ipswich Greyhound Racing Club Inc.

### TERMS AND CONDITIONS

#### 1. ELIGIBILITY

- All greyhounds nominated must be whelped in the period 1<sup>st</sup> October 2016 – 1<sup>st</sup> May 2017 inclusive.

#### 2. FEES

- Nomination Fee is \$100 per pup.

**Prior to 30-07-17 the Ipswich Greyhound Racing Club Inc. reserves the right to cancel the sale through lack of nominations – All nomination fees will be refunded. Cancellations after the Catalogue is published will not be eligible for refund.**

#### 3. COMMISSION

The Club will charge a fee of 13.75% (GST inc) of the purchase price at the time of sale, which will be deducted from the purchase price.

#### 4. NOMINATIONS

- Nominations for the Auction close on 30<sup>th</sup> June at 3.00 pm with the club.
- All nominators for the sale will be notified in writing of their acceptance.
- **The nomination form must be completed in full including all breeding details. If a puppy ear brand and micro-chipped is not done at the time of nomination, please specify on what date this will be done. A reasonable amount of information on the puppy's background must be included with each nomination. Eg Dams race track record, success of previous litters, close relations. Any nomination, which is not complete, may not be considered.**
- The Ipswich Greyhound Racing Club Inc. recommends that you (as nominator) of a Greyhound/s at the Year 2017 Auction seek your own/independent CPA advice in respect of any GST requirements arising from the sale.

#### 5. PRIZEMONEY AND BONUSES

##### PRIZEMONEY

- The prize money for Heats and Semi-Finals to be as per normal race day prize money.
- **The Final Prize money will be 1<sup>st</sup> - \$40,000, 2<sup>nd</sup> - \$10,000, 3<sup>rd</sup> - \$5,000, 4<sup>th</sup> - \$1,500 Unp \$500.**

##### BONUSES (WINNER OF FINAL)

- **Breeder Bonus - \$2,000.**

#### 6. CONDITIONS

- Bidding commences at \$800 per pup.
- All greyhounds accepted for the sale must be kennelled on the day of the sale at the time the Club notifies.
- All greyhounds accepted for the sale must be in a fit and clean condition. Any pup deemed by the veterinarian not in a suitable condition shall be withdrawn from the Auction. Any pup found to be in a condition deemed by the veterinarian to be unfit through lameness of injury shall be withdrawn. It is the responsibility of the nominator to advise the club of any known conditions that may affect the saleability or the racing ability of the puppy.

- A separate vaccination certificate confirming hepatitis, parvo and distemper vaccinations current to and including the date of the Auction must be produced at kennelling time. Failure to provide the vaccination certificate will result in the pup being withdrawn from the Auction.
- Any greyhound withdrawn by the Veterinarian shall be ineligible for any race in the Series.
- It is a prerequisite of the club that all greyhounds selected for the sale must be puppy ear branded micro chipped prior to the nomination and presented with puppy papers and transfer of micro chipped number which must be signed by owner. These will be held in office until the completion of the auction.
- All greyhounds accepted for the sale will be paraded in the sale ring by the nominator or his/her appointee. The nominator is responsible for producing the greyhound with a collar and lead.
- The Club will collect all proceeds from the sale and deduct the appropriate fees and the remainder of which shall be forwarded to the nominator within 21 days.
- Payment by cheque will mean that puppy papers will be held by the Club for 21 days from the Auction.
- The only exception will be that, should the highest bidder for a greyhound also be nominator then the greyhound will be released by the Club to that person upon payment of the fee being 13.75% (GST inc) of the purchase price.

## **7. RACE**

- Nomination for the heats must be lodged with Racing Queensland before the closing date of the first week of heats of the series. Closing time for nominations for the race to be advised at a later date.
- It is the purchaser's responsibility to notify the club in writing of change of ownership or change of address. The Club will not be held responsible for any problems arising from failure to do so.
- Heats (as many as required) and Semi-Finals will be conducted for the race.
- All lots sold on the day of the sale are eligible for the race series in 2019.
- A one off final acceptance fee of \$100.00 will be payable by the purchaser by the 30<sup>th</sup> January 2019 to be eligible for the race. The Club will notify all purchasers by mail in December 2018 of details for this final acceptance fee, if you haven't received any correspondence it is the purchaser's responsibility to contact the Club otherwise a late acceptance fee of \$550.00 can be paid at time of close of race nominations if the final acceptance fee has not been paid.
